<u>Services will be discontinued if you are 2 weeks behind in your payments</u>. Your services will begin again when you have paid your past due balance in full.

*Late Pick-Up Fees:* There will be a \$5.00 charge <u>for every 5 minutes after the contracted time</u>. We understand that everyone will face an occasional mishap.
